Excellent presentation – explain myths, misconceptions, stigmas regarding substance use disorders, the individuals and treatment / This power point and other material will be provided as requested / Lisa Hoeschele (Family & Children's Counseling Services) this information would be helpful to share with Drug Court and other public servants to broaden awareness of other types treatments and the other issues covered in this presentation / Lisa Skill – OASAS has completely changed its operation into one of harm reduction because of increased education and leaders who understand the science behind addiction and treatment – much of the success of education relates directly with the messenger / also challenging people to change the language – can change the message / Chair Matt Whitman thanked Lisa Skill for the presentation

Matt Whitman (Director of CACTC): Because of the short amount of time remaining, Matt asked any agency representatives to forward updates to share, to Gail Spitzer to include with these minutes gspitzer@cortland-co.org

Increase in number of overdoses recently but also in 2020 and how can this committee help to address these issues in our County – Lisa Hoeschele: had a conversation with the Cortland City Mayor, Brian Tobin – there will be a presentation at the City Council meeting on February 16 – intended to heighten awareness of the current opioid crisis in our community / Amanda (Mandy) Stout F&CCS – since October of 2020, have handed out 108 Narcan kits – working closely with Sara Watrous (CACTC – HEALing Communities), have two scheduled weekly Zoom call-in events / pop-up events (to educate and distribute Narcan kits) distributed 42 kits in two hours at an event in December / eleven "train the trainer" events upcoming – monthly pop-up events planned
