WHEREAS, Local Law No. 1 for the year 1987 providing for an increase in salary for the: County Attorney, District Attorney, Director of Real Property Tax Services, Personnel Officer, Commissioner of Elections Representing the Republican Party, Director of Public Health, Commissioner of Social Services, Director of Planning, County Highway Superintendent, Director of Veterans Service, was introduced by Mr. Palm, a member of this Legislature at the November 26, 1986 Legislative Session, and
