  - Director, Real Property Tax Services . . . . . 20,024.00

  - Chairperson, Civil Service Commission . . . . . 2,295.00
  - Commissioners, Civil Service Commission (2) . . . . . 1,350.00 each
  - Superintendent of Highways . . . . . 29,773.00
  - Director, Community Services . . . . . 31,364.00
